#### **PREFACE**

The Directorate General Factory Advice Service and Labour Institutes (DGFASLI), Mumbai is an attached office of the Ministry of Labour and Employment, Government of India to serve as a technical arm to assist the Ministry in formulating National Policies on Occupational Safety and Health and to advise the State Governments and Factories on matters concerning Safety, Health and well being of persons at work. Even though the Personal Protective Equipment (PPE) are always recommended as the last line of defense, its relevance in ensuring safety and health of the workers is of paramount importance considering the prevalence of non – preventable and uncontrolled hazards at workplaces. PPE is not regarded as an alternative to engineering or other suitable control measures but should be provided and maintained where such control measures cannot ensure protection. It is the responsibility of the management to provide and enforce the use of PPE among the workforce. The PPEs before issue shall be checked for its compliance to the Indian Standard, reliability, condition of PPEs such as damaged or in need of service or repair by a qualified person. The PPEs shall be stored and maintained according to manufacturer's instructions.

Hence it is imperative to emphasis upon different types of PPE such as respiratory and non-respiratory personal protective equipment, their use, maintenance and storage. In the interest of protecting the values of the workforce by imparting knowledge on the selection, procurement, use, maintenance and storage of PPE, Regional Labour Institute, Chennai is conducting this one day National Seminar.
