

BACKGROUND

The Directorate General Factory Advice Service and Labour Institutes (DGFASLI), Mumbai is an attached office of the Ministry of Labour and Employment, Government of India to serve as a technical arm to assist the Ministry in formulating National Policies on Occupational Safety and Health and to advise the State Governments and Factories on matters concerning Safety, Health, Efficiency and well being of persons at work. It also enforces safety and health statutes in major Ports of the country.

Regional Labour Institute is one of the Subordinate Offices of DGFASLI, Government of India, Ministry of Labour and Employment with the objective of providing technical advice to State Governments and to the Industries in the southern region. This organization is poised to grow further to meet the increased demands of the industries and society. Regional Labour Institute, Chennai has also been declared as a Centre of Excellence for Construction Safety and a Construction Safety Cell has been constituted and functioning at RLI, Chennai.

OBJECTIVES

Majority of industries use some kind of Lifting Machines and Tackles for Material Handling in their manufacturing process. Though the use of Lifting Machines and Tackles is an important element of any production activity, sometimes faulty selection, inadequate strength, patent defects, poor operating practices, etc. may cause serious accidents resulting in injury, fatalities, damage to plant and equipment or other facilities.

To prevent such unwarranted events, it is pertinent that users of these equipment are familiar with the various requirements relating to the design, construction, testing and examination, maintenance and safe operation of the equipment. These equipment are also required to be periodically examined and tested as per the provisions under Factories Act / Rules, BOCW Act / Rules, Dock Workers (Safety, Health & Welfare) Act, 1986 and Regulations, thereto.
