## “ASSOCIATE FELLOW OF INDUSTRIAL HEALTH” (AFIH- 2014-15)

APPLICATIONS are invited in the prescribed form for admission to 3 months full time Post Graduate Certificate Course in Industrial Health (AFIH) commencing from 1st December, 2014 to 27th February, 2015 at **REGIONAL LABOUR INSTITUTE, SECTOR – 47, FARIDABAD - 121010 (HARYANA)**

On completion of the three months teaching curriculum, an examination will be held and successful candidates will be awarded “**ASSOCIATE FELLOW OF INDUSTRIAL HEALTH**” which will fulfil the requirements in terms of additional qualification of Factory Medical Officers of Hazardous Process Industries as required under the Factories (Amendment) Act, 1987.

### Eligibility for Admission:

1. MBBS Degree from an Institution recognized by the Medical Council of India.
2. Completion of Internship.
3. Permanent Registration with the Medical Council of India /State Medical Council.
4. Minimum one year experience as a full time Medical Officer in Occupational Health related work in hazardous industry or 2 years in general practice after the date of completion of internship.

**Fee:** Rs. 2400/- (likely to be revised) payable by Demand Draft as Institute fee to be paid at the time of admission.

**Reservation:** For SC/ST/OBC/PH candidates (As per Government of India rules)

### Course contents:

1. Theory: Various aspects of Occupational Health and Industrial Medicine Practice.
2. Practical and clinical training, educational visits, group discussions, project work etc.

### Last date for the receipt of applications is 31<sup>st</sup> October, 2014

Applications, completed in all respects, along with DD and attested photo copies of certificates should reach to “**The Deputy Director (Medical), Regional Labour Institute, Sector – 47, Faridabad –121010 (Haryana)**” by Speed Post /Registered Post only. Demand draft of Rs.100/- (Rs.50/- in case of SC/ST candidates) towards “Registration Fee” drawn on any nationalized bank, should be in favour of “Regional Labour Institute” payable at Faridabad. The envelope containing application should be superscribed “**APPLICATION FOR ADMISSION IN AFIH**”.

Applicants working in Govt. /Public sector undertakings /Autonomous Bodies etc. should apply through proper channel. Incomplete applications will be summarily rejected.

**Selection:** Shortlisted candidates will be informed by speed post /e-mail /mobile for interview at Regional Labour Institute, Faridabad. The decision of the selection committee shall be final. No TA/DA will be paid for attending the interview. The candidates should produce all the certificates and documents in original at the time of interview.

**Accommodation:** AC /Non AC, non family, twin sharing accommodation is available in the trainee hostel located in the institute campus at nominal rates.
