Section 4

Description and definition of Success Indicators

1. Up-gradation of Labs. in CLI & RLIs of DGFASLI

The various Labs in the Central Labour Institute and Regional Labour Institutes, at Chennai, Kolkata, and Kanpur have been set up in 60's, which requires up-gradation both in terms of equipment replacements in line with latest state of art and requirements under the various BIS Standards for testing, experimentation and analysis of data/ samples collected. The Labs also need to be modernized with the provision of ambient working atmosphere and infrastructure such as working platforms, shelves, racks, work stations, etc.

2. Provide technical advice to State Govt.

Various requests are received from Chief Inspectors of Factories, Labour Secretaries and from the industries and trade union from the States and Union Territories on the matters concerning with interpretation and implementation of The Factories Act, 1948. Accordingly, technical advices are provided to the concerned authority/ organization/ industry/ trade union representative

3. Conduct of seminars, workshops, etc.

National and Regional and Unit level seminars, workshops are organized by DGFASLI through its Central and Regional Labour Institutes on the matters related to Occupational Safety and Health at workplace for creating awareness and addressing the issues and challenges in the field of Occupational Safety and Health to draw up suitable action plan for implementation by various stakeholders. These seminars / workshops will be organized by the DGFASLI individually or in collaboration with organizations through Public, Private Partnership (PPP).

4. Conduct of studies, surveys, safety and health audits, etc.

National, Regional and Unit level consultancy studies are undertaken by DGFASLI through its Central and Regional Labour Institutes on the matters related to Occupational Safety and Health at workplace. The Unit level consultancy studies and safety and health audits are undertaken based on requests received from industries / ports.

5. Providing technical advice to industry including approval of FLP, testing of PPE, etc.

Based on request from the manufacturers, approval for flameproof equipment and testing of Personal Protective Equipment request from the manufacturers & users, testing and performance certificate in respect of both respiratory and non-respiratory are given. The samples of the PPE are tested as per the relevant BIS Standards for their performance.

6. Conducting one year Diploma in Ind. Safety Course

The appointment of safety officers in the manufacturing and port sector is a statutory requirement as per section 40-B of the Factories Act, 1948 and Regulation 1993 of the Dock Workers (Safety, Health & Welfare) Regulations, 1990, which specifies qualification and experience to be possessed by the safety officers. The DGFASLI, through its Central and Regional Labour Institutes, conduct the One Year Diploma Course as per the requirements of the respective State Technical Boards for the award of the Diploma Certificates.

7. Conducting 3 month certificate Course -AFIH

Under Section 41-C(a) of the Factories Act, 1948 the occupier in relation to hazardous process industries shall maintain accurate and up-to-date health records of the workers in the factory who are exposed to any chemical or toxic substances, require that the factory

medical officers are trained and possessed a certificate of training in industrial health of a minimum duration of three months recognized by the State Governments.

8. Conducting one month certificate Course for Supervisors employed in hazardous process Industries

The Factories Act, 1948 has a specific requirement under section 41-C(b) to appoint persons who possess qualifications and experience in handling hazardous substances and are competent to supervise such handling within the factory and to provide at the working place all the necessary facilities for protecting the workers in the manner prescribed. DGFASLI conducts one-month certificate course for supervisors employed in hazardous process industries.

9. Inspection of Ships, Gears and Docks, etc

The Dock Workers (Safety, health and Welfare) Act, 1986 and Regulations, 1990 are being enforced by the DGFASLI through the Inspectorates of Dock Safety in the 12 major Ports. The Act covers the loading and unloading operations. In order to ensure the safety, health and welfare of the dock workers, the Inspectors of Dock Safety carry out inspections of ships, gears and dock areas.

10. Accident investigation

The accident to the dock workers are investigated by the inspectors of dock safety for both fatal and non fatal injuries in the port premises while carrying out the loading and unloading of the cargo. Prosecutions are launched in the Court under the Dock Safety Statutes.

11. Conduct of promotional activities like participation in Safety Committee Meetings and Safety Weeks Celebrations

The Inspectors of Dock Safety participate in the Safety Committee meetings and Safety Week Celebrations in order to promote safety, health and welfare of the dock workers.

12. Creating awareness on various aspects of safety and health in industries

DGFASLI organization conducts specialised seminars and workshops in the field of Occupational Safety and Health including an intensive workshop on "Higher Productivity and Better Place at Work" to small and medium enterprises as per the ILO Guidelines.

13. Conducting of the Awards Distribution Ceremony once in a year

The Awards Distribution Ceremony is held annually in the month of September/October and awards are distributed to the winners at New Delhi. A total of 240 awards are given to different categories of industries and major ports under National Safety Awards and 28 Awards are given under Viswakarma Rashtriya Puraskar Awards.

14. Mandatory Success Indicators

Each Responsibility Centre must ensure timely Submission of RFD for 2011-12 and Submission of RFD Results for 2011-12, finalise a Strategic Plan for Responsibility Centre, identify potential areas of Corruption related to organization activities and develop action plan to mitigate them and Implementation of Sevottam compliant system to implement, monitor and review Citizen's Charter and to redress and monitor Public Grievance to promote enhanced and sustainable performance levels

Section 5

Specific performance requirement from other departments that are critical for delivering agreed results (Constraints)

1. The majority of the activities being undertaken by this organization depend upon the availability of manpower. It would be difficult to achieve many of the targets due to depleted manpower, abolition of posts and non filling up of vacant posts during the last 5 years.
2. Up-gradation of various labs of CLI would depend upon the procurement of critical equipment from abroad and modernization of these labs under minor works would depend upon the cooperation and execution by the CPWD.
3. To achieve the targets it is proposed that some of the activities like workshops, seminars would be undertaken through encouragement of Public – Private – Partnerships (PPP)
4. The number of inspection of ships, gears and docks in the major ports would depend upon the number of cargo ships calling in these ports.
5. The adoption of Model Rules by the /state government depends upon following the procedures/ approvals by the concerned state governments.
6. Carrying out of testing of PPEs and granting of approval of FLPs would depend upon the receipt of request from the manufactures and the users of these equipment.
7. Conduct of various training programmes, seminars would depend upon nomination of the delegates by the various stakeholders, i.e., industries and employee representatives.
8. Conduct of consultancy studies, surveys and safety audits would depend upon receipt of request from industries
