
IDS, Paradip intends to hire one Non AC Car Light Motor Vehicle with Fuel & Driver per day basis on the following terms and conditions.

Heads	Conditions
Service	Provision of commercial vehicles with licensed drivers, registered commercial vehicles on hiring basis for running in Paradip, Odisha with valid port entry permit issued by Paradip Port Trust.
Period of Contract	Under normal circumstances the contract shall be valid for a period of one year from the date of issue of work order. However contract may be extended for further period up to two years if agreed by the contractor and IDS, Paradip on the same rate, terms and conditions and performance.
Duty hrs.	03 hours and 30 Kms. per day as and when required. However vehicle must be available in case of emergency at any time even on holidays also.
Notice Period of requirement	For regular requirement - one day in advance and for emergency - two hours in advance. Telephonic intimation shall be considered as a notice.
Counting of Distance	Distance shall be counted from garage to garage. But chargeable distance in this respect shall be maximum 02 kms. each way or whichever is less.
Special Conditions	<ol style="list-style-type: none">1. Intending bidder must have a Telephone/Mobile phone where requirement of requisition of vehicles can be conveyed all the 24 hrs. and telephone number must be specified in the bid.2. Payment of any Govt. Tax or duty for plying the vehicle in Odisha will be liability of the contractor.3. Parking and Toll charges, if any, may be claimed by producing the Parking /Toll Slips.4. In case of any accident all liabilities will be borne by the bidder. IDS, Paradip will not be responsible in any circumstances.5. In case of any break down, vehicle has to be replaced immediately.
Payment Terms	Bill will be submitted in triplicate to the authority specified in contract along with duty slips duly signed by the user on the end of the month.
Daily Rate for 3 hrs. & 30 Kms.	Rate will be based on irrespective of fuel price. However extra Kms., extra hrs. and night halt charges may be indicated separately.

In this connection, it is mentioned that as the contract for the full year will be given to the party quoting the lowest rate, but the payment will be made on monthly basis. Director (Safety), Inspectorate Dock Safety, Paradip and should reach this office on or before 3rd October, 2017 by 1500 hrs.
