Heads	Conditions
Service	Provision of commercial vehicles with licensed drivers, registered commercial vehicles on Hiring basis for running in West Bengal State.
Period of Contract	Under normal circumstances the contract shall be valid for a period of one year from the date of issue of work order. However contract may be extended for further period up to two year if agreed by the contractor and IDS, Kolkata on the same rate, terms and conditions and performance.
Duty hrs.	Ten hours per day and 80 Km as and when required. However vehicle must be available in case of Emergency at any time even on holidays also.
Notice Period of requirement	1) For regular requirement one day in advance and for emergency two hours in advance. 2) Telephone intimation shall be considered as notice.
Counting of distance	Distance shall be counted from garage to garage. But chargeable distance in this respect shall be 05 km each way or whichever is less.
Penalties	In case of break down, vehicle have to be replace immediately or not more than one hour. In case of non availability of suitable vehicle a penalty up to Rs.200/- may be imposed in addition to deduction on pro-rata basis for the period.
